30th Annual Cobia "Big Fish" Tournament June 7th & 8th, 2014

RULES

- (1) I.G.F.A RULES WILL GOVERN. We will go over the rules at both of the Captain's Meetings on Friday June 6th at 5:00 PM & 7:00PM at MacRae's of Homosassa, plus you will get a copy of the rules in your ditty bag. The captain of each boat will sign an acknowledgment of receiving and accepting these rules governing this tournament at the time of registration. Registration will be held Friday June 6th beginning at 4:00PM. NOTE: Attendance is not required at both meetings. Two meeting times have been scheduled to accommodate a large turnout.
- (2) Maximum Line Test 80#. Maximum of 6 lines in the water at any one time.
- (3) Boats may leave by the Homosassa River or Crystal River, but must return by the Homosassa River, directly to <u>MacRae's Bait & Tackle Weigh Station</u> or that days catch will be disqualified.
- (4) If either Saturday's or Sunday's fishing is cancelled by the Weather Committee due to bad weather, and one day is fished, the tournament will be over and the results will be determined from the one day of fishing. If both days are lost due to weather, the Tournament will be rescheduled for June 14th & 15th, 2014. There will be no refunds of entry fees once paid.
- (5) All fish must be of legal size. We encourage quick release of small or unwanted fish.
- (6) All tournament boats must fly their tournament flag from checkout to check-in. Tournament boats must stay clear of all other boats unless cleared by a committee boat.
- (7) In case of a tie, the monies will be added together and divided.
- (8) All fish must be hooked, fought and caught on a rod and manual reel, by an unassisted angler. An assisting fisherman may touch the leader as long as no other part of the rod, reel or line is touched. (IGFA Rule #1 under Angling Regulations).
- (9) FISHING HOURS- Both Days Check Out-7:00AM (earliest). Check-in by 4:00PM (latest).

FAILURE TO CHECKOUT OR CHECK-IN BY 4:00PM DEADLINE WILL DISQUALIFY THAT DAYS CATCH! The time shall be kept by the Committee. Anyone arriving after the 4:00PM deadline will be disqualified, unless by exception contained in these rules.

(10) Entry Fees & Registration – All entry fees must be in by 7:00 AM-Saturday, June 7th, unless specifically approved by tournament committee in writing. Registrations by mail must be received no later than Tuesday, June 3rd, 2014. Registrations can also be dropped off at Twin Rivers Marina, Blue Water Bait & Tackle, Ed's Bait & Tackle or MacRae's of Homosassa before Friday May 30th, 2013. Registrations after May 30th, 2014, can be dropped off at MacRae's or at the Captain's Meeting. (Maximum 200 Boats)

- (11) Any protest must be in writing and in the hands of the tournament committee by 4:30PM on each day of the tournament. The Committee shall review all protest complaints. The Tournament Committee in its sole discretion shall determine what, if any, tests shall be conducted on the challenged fish. Furthermore, all anglers entered in this tournament agree to any and all requests from the Tournament Committee for testing necessary to the determine the angler's compliance with the rules and regulations of this tournament. Decisions by the Tournament Committee are final and binding.
- (12) Any boats aiding or in a rescue situation that has been asked to do so by the committee will be allowed to weigh-in late. The aided or rescued boat will not be allowed to weigh-in late.
- (13) No angler can win more than one "Cobia" award but can win a Cobia Award and still be eligible for the grouper, trout and redfish awards.
- (14) Checkout location: MacRae's Bait & Tackle (Homosassa River) or down the canal from Twin Rivers Marina (Crystal River).

(15) WEIGH-IN FOR ALL ANGLERS: MAC RAE'S BAIT & TACKLE! FISH MUST BE BROUGHT TO WEIGH-IN BY BOAT ONLY! LEAVE ALL FISH IN BOAT UNTIL YOU PULL UP TO SCALES. THERE WILL BE NO WEIGH-IN'S AT CRYSTAL RIVER.

(16) **TOURNAMENT RADIO CHANNEL-VHF Channel 72.** It is recommended that all boats have a VHF radio. If not make arrangements to "Buddy Boat" with someone who does. Alternate Channel is 68.

(17) **COMMITTEE BOATS-** There will be committee boats north and south of the Homosassa River. All potential winning fish should be reported to a committee boat as soon as possible after landing a fish.

COMMITTEE BOATS: To be announced at Captain's Meeting.

(18) Raffle Tickets to be given out for donated eligible species: Cobia, Grouper, Trout, Snapper, Redfish, and Flounder.
